### **Important Information about Your Retiree Medical Benefits**

Dear Medicare-Eligible Retiree and/or Spouse or Dependent,

We are pleased to inform you that effective January 1, 2023, there will be improvements to your Medical Coverage under your plan. These changes are being made to enhance your personal benefits, improve your member experience, and strengthen the financial position of the NECA-IBEW Welfare Trust Fund ("Fund").

Your Medical coverage will now be provided by **Humana Medicare Advantage Plan (MA)** effective January 1, 2023.

The Fund has retained Labor First, a firm that specializes in the implementation of and the ongoing member services for Union Retiree Medical Plans, to help you with this change. You will have a dedicated group of Retiree Advocates who will work with you to assist in creating a smooth transition, provide ongoing support for your coverage under the Humana plan, and answer any of your questions or concerns.

### **Plan Improvements:**

- You will no longer have a Part B deductible
- Added Podiatry coverage \$0 copay, 6 visits per year
- Added Silver Sneakers fitness program

#### <u>Important Things to Know:</u>

- You must continue to be enrolled in Medicare Parts A and B to participate in the Humana Medicare Advantage (MA) plan.
- You can use any willing Medicare provider, regardless of if the provider is in or out of the Humana Medicare Network.
- No referrals are needed for all Medicare covered Medical Services.
- There will be no change to your current prescription plan. You will continue using SilverScript / CVS Caremark for your prescription needs.

#### What mailings to expect in the coming months:

- First you will receive a Humana Pre-enrollment Kit.
- Then the Humana Welcome packet and ID card will be mailed. Please keep in mind each member will receive an ID card and they may arrive on different days, this is normal.
- Finally, you will receive a Humana Evidence of Coverage.

We are required by law to give you the choice of opting out of the new plan. Please note that since you are currently enrolled in the NECA-IBEW Welfare Trust Fund Supplemental Retirement Benefit Plan, there isn't likely to be any reason why you would not participate in the new Humana Medicare Advantage (MA) plan. However, you have the option to opt-out. If you would like to opt-out, please call Toll-Free 855-433-1668 (TTY 711) to discuss with a dedicated NECA-IBEW Welfare Trust Fund Labor First Retiree Advocate.
