### IMPORTANT NOTICE TO PARTICIPANTS

The Employee Retirement Income Security Act of 1974 requires the Board of Trustees to notify you of certain changes in the NECA-IBEW Pension Trust Fund's Plan Document and Summary Plan Description ("SPD"). This Summary of Material Modifications ("SMM") is a summary of the recent changes, effective as noted.

#### No Retirement Declarations for Participants Who Reach Age 70 1/2

Effective June 1, 2024, the Plan Document has been amended to clarify that the Fund does not require a Participant who has reached age 70 ½ to cease working in Covered Service nor require such Participant to complete and submit a retirement declaration in order to receive a retirement distribution. This update to the Plan Document is a clarification of (not a change in) Plan practice.

#### **Exempted Employment: Inspectors**

Under the Plan, certain types of work are not permissible once you retire and begin receiving your pension payments. This work is called "disqualifying employment." In general, "disqualifying employment" is work for at least forty (40) or more hours in a month that is within an "Industry," "Trade or Craft," and "Geographic Area" as defined by the Plan. (See your summary plan description for more details on this type of employment.) If you engage in work that is considered to be "disqualifying employment," your pension payment is subject to suspension.

Effective June 1, 2025, work performed by a retired Participant who is at least age 60 as a building or code inspector by a city, county, state, or national government is not considered to be "disqualifying employment" if the inspector position is not covered by a Collective Bargaining Agreement as defined in Section 1.06 of the Plan Document. This means that your pension payments will not be subject to suspension if you engage in this type of work.

#### New Money Rate

The Board of Trustees amended the Plan Document to include the following language:

Employer Contributions made on a Participant's behalf by an Employer who first begins participating in the Plan on behalf of a new bargaining unit or group on and after January 1, 2017, shall only be subject to the New Money Rate multiplier specified above (i.e., the Old Money Rate multiplier that applies to Employer Contributions remitted prior to January 1, 2017, is not applicable). The foregoing provision applies to Employer Contributions made by Employers who first participated in the Plan on or after January 1, 2017 with respect to a new bargaining unit or group (i.e., Employer Contributions made on a Participant's behalf by an Employer who became signatory to an area-wide or other collective bargaining agreement that required Employer Contributions to be paid to the Pension Fund prior to January 1, 2017 by other Employers, or an Employer who participated in the Plan prior to January 1, 2017, and then withdrew or terminated participation and subsequently resumed participation after January 1, 2017, shall be subject to the Old Money Rate and New Money Rate, as applicable).

This update to the Plan Document is a clarification of (not a change in) Plan practice.
